TRADING AGREEMENT AND ORDER MODIFICATION NO. 2

In the matter of a Trading Agreement and Order between the Commissioner of Environmental Protection ("Commissioner") and the Connecticut Resources Recovery Authority ("CRRA").

WHEREAS, the Commissioner and CRRA, having agreed to the terms and conditions set forth in Trading Agreement and Order No. 8116 issued on April 22, 1997 and Trading Agreement and Order No. 8116 Modification issued on April 29, 1999, do now, by mutual agreement, modify paragraphs A.5, A.6., B., D.2., D.7. and D.13. as follows:

1. Add a sentence to paragraph A.5. as follows:

On May 3, 1998, CRRA, through its contractors, completed installation and began to test and make fully operational, SNCR systems on Units 11 and 12.
2. Change the date specified in paragraph A.6. as modified on April 29, 1999 from December 14, 1999 to December 19, 2000.
3. Change the first date specified in paragraph B. as modified on April 29, 1999 from December 14, 1999 to December 19, 2000 and change the second date specified in paragraph B. as modified on April 29, 1999 from December 14, 1999 to December 19, 2000.
4. Change the second date specified in paragraph D.2. as modified on April 29, 1999 from December 14, 1999 to December 19, 2000 and change the third date specified in paragraph D.2. as modified on April 29, 1999 from December 14, 1999 to December 19, 2000.
5. Change the date specified in paragraph D.7. as modified on April 29, 1999 from December 14, 1999 to December 19, 2000.
6. Change the date specified in paragraph D.13. as modified on April 29, 1999 from December 14, 1999 to December 19, 2000.
