

EPA's 2025 Air Sensors Workshop

People, Process, & Performance: A Pathway to Impact

March 18-20, 2025 Research Triangle Park, NC



Thank you for your interest in exhibitor and support opportunities at **EPA's 2025 Air Sensors Workshop to be held** March 18 - 20, 2025.

The workshop will take place at the Sheraton Imperial Hotel in Research Triangle Park (RTP), North Carolina. We anticipate between 800 and 1000 hybrid attendees (~250 in-person), providing you with the opportunity to meet potential users, purchasers, and decision-makers who may be interested in your equipment and services.

EVENT OVERVIEW

Air agencies, community groups, and other organizations are rapidly installing air sensor networks across the United States and the world. For many, the goal of collecting local air quality information is to create avenues for change and improve human health. The 2025 Air Sensors Workshop aims to 1) discuss the processes, tools, and engagement strategies that enable impact, and 2) highlight success stories and potential practical outcomes utilizing air sensors.

WORKSHOP FORMAT

Hosted in the Ballroom at the Sheraton Imperial, the 2025 Air Sensors QA workshop will be a three-day hybrid event for both in-person and virtual attendees. This year's event will include presentations and panel discussions with various community monitoring and air sensor stakeholders. The event will provide a forum to discuss basic air sensor policies and practices, tools for impact, community engagement, study results, and more.

EXHIBITOR OPPORTUNITIES

There are 15 in-person exhibit spaces available at the Sheraton and 5 online-only exhibit opportunities using Whova, a popular hybrid event platform. Every exhibitor will have the opportunity to create an exhibit space within the Whova platform. There will be 20 total exhibitors.

Attendees will have the opportunity to visit the exhibit area at any time during the workshop. From past events, we have seen attendees visit the exhibit area before the workshop each day, during a mid-morning break, lunch, during a mid-afternoon break, and during the evening social networking event.

SOCIAL NETWORKING

A networking event will be held in the exhibit area on Wednesday evening, with the exact details to be determined.

EXHIBIT SETUP

Exhibit setup will take place on Monday, March 17, 2025, from 2:00 - 6:00 PM ET. <u>ALL exhibitors</u> <u>are REQUIRED to be set up by Monday evening</u>. The exhibit area will open Tuesday. An opening reception will be held in the exhibit area on Wednesday evening. If we have adequate support, we will be able to offer refreshments in the exhibit area.

While the exhibit space is free of charge, there are other associated fees and responsibilities you will be responsible for, such as packaging materials and freight.

EXHIBIT TEAR-DOWN


Exhibit tear-down will occur on Thursday, March 20, 2025, between 2:00 - 5:00 PM.

EXHIBIT AREA

This specialty workshop should not be confused with a larger-scale event like EPA's National Ambient Air Monitoring Conference. There is no exhibit hall; rather, exhibit tables/booths will be set up along the exterior of the Ballroom (highlighted area in the graphic). Exhibit space will be assigned on a first-come, first-served basis. Exhibitors will be informed of their acceptance by mid-November 2024.



VIRTUAL VENUE
