#### Conferences and meetings

#### [Transportation Research Board Annual Meeting](#) (January 5 – 9, 2025)

Engage with transportation-related construction industry stakeholders. Members of our team will also moderate an interactive discussion during the [session titled “Next Steps in Green Labels”](#) focused on how EPDs can be integrated into the procurement process to deliver sustainable infrastructure projects. Following the conference, EPA will host a workshop for invited asphalt stakeholders to gather input on our threshold-setting process.

#### [NGA Glass Conference](#) (February 3 – 6, 2025)

EPA staff are planning to attend and engage with glass industry stakeholders including flat glass manufacturers and glass processors. EPA is currently exploring opportunities to have collaborative conversations with industry on glass EPDs and low embodied carbon developments in the sector at this event.

EPA staff are planning to attend and will engage with concrete industry stakeholders. EPA is currently exploring opportunities to have collaborative conversations with industry on concrete EPDs and low embodied carbon developments in the sector at this event.
